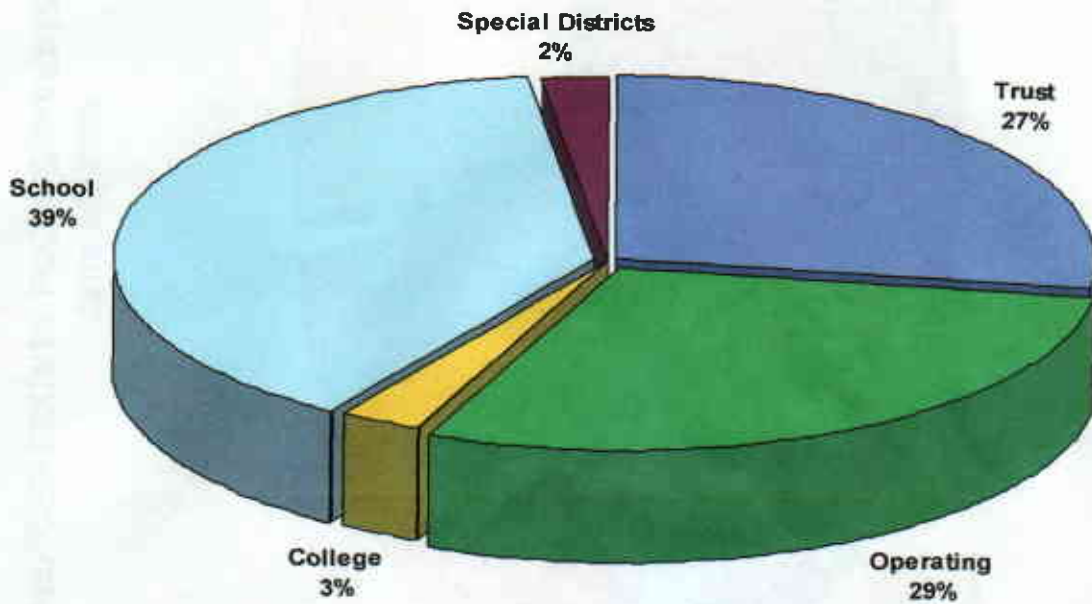

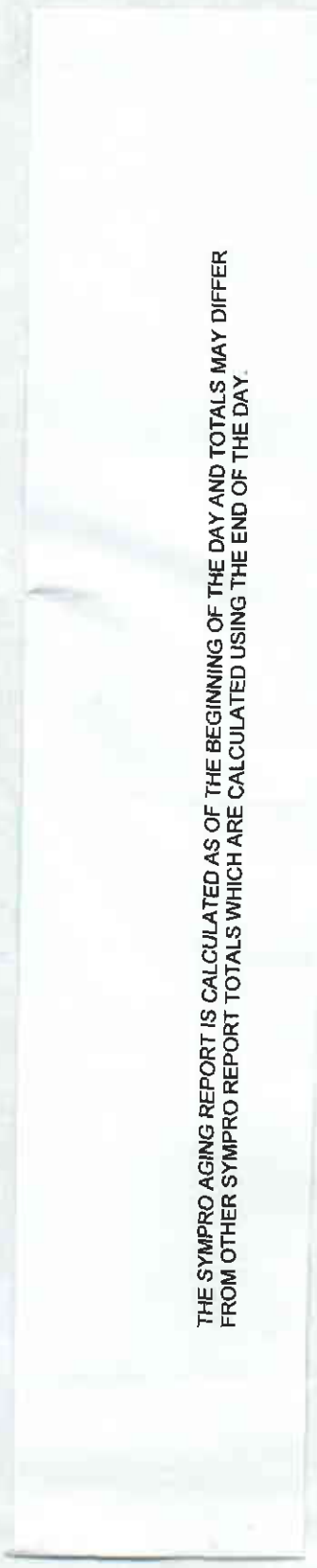

Portfolio Review

Karen reviewed the Quarterly Investment Portfolio Composition figures for the Pooled Investments for the Quarter Ending March 31, 2009. The Book Value of Assets Held was \$631,547,636. The Market Value of Assets Held was \$638,288,162. The category showing Assets Maturing within 90 Days has a quarterly total of \$380,113,375. The percentage of Market to Book Value was at 1.1067%. The Weighted Average Maturity (WAM) was 236 days.

The Return of Assets figures were also reviewed. Total Earnings for the Quarter were \$4,394,618 and the Total Earnings Fiscal year-to-date were \$14,849,916. The rate of return for the quarter was 2.83%, rate for the fiscal year of 3.25%.
