Health Order Amendment Includes Requirements for Social Distancing and Safety Plans

MERCED COUNTY, CA – Merced County Health Officials amended the current Stay-At-Home Order (Order) today to include minimum requirements for social distancing and safety plans for essential businesses. The Order also expands the definition of essential services to include drive-up services for faith-based organizations, animal care facilities, drive-through automatic car washes, and pool maintenance. The amended Order is effective immediately and supersedes the prior Order issued on April 17, 2020.

“In an effort to align Merced County’s Stay-At-Home Order with the Governor’s Order, changes were made to provide clarification to the essential services in our community and to assist with social distancing and safety plans,” said Dr. Rebecca Nanyonjo-Kemp, the Department of Public Health Director. “It is our hope that the changes to the Order will promote public health and safety and still allow for essential services to thrive in our community.”

Although the Order has been amended, it’s important that social distancing and safety measures remain, as we’re still at-risk for a surge of transmission in our community. The Order allows for faith-based organizations to provide weekly services through streaming or other technologies or by conducting drive-up services, where the patrons remain in their vehicles. Services must abide by physical distancing guidelines and individuals must refrain from direct or indirect contact with others.

Animal care facilities are now added to the essential list of businesses. This includes facilities that provide food, shelter, veterinary and/or routine care and other necessities of life for animals.

Additionally, drive-through automatic car wash businesses, where customers remain in their vehicles with no cash exchange, are now deemed essential. Vacuum centers associated with car washes shall remain closed. Social distancing must still occur with a six-foot distance between customers and employees.

Moving forward, Merced County will continue adding to the list of essential businesses when possible, however, local entities (such as Merced County) must operate within the confines of the Governor’s Executive Order and cannot supersede its directives.

All essential businesses shall be required to develop a Social Distancing and Safety Plan. The minimum requirements that must be included in the plan are:

- Limit capacity of business to 5 people per 1,000 square feet.
- Door monitoring of individuals in/out to ensure appropriate capacity is maintained.
- One adult may enter the business per party/cart. No large family visits.
- Social distancing must be ensured (see details in amended Order).
- Employees shall wipe down all carts and baskets using disinfectant.
- Provide adequate handwashing facilities for employees.
- All employees must wear cloth masks, provided by employer.

ORDER OF THE HEALTH OFFICER
OF THE COUNTY OF MERCED DIRECTING ALL INDIVIDUALS LIVING
IN THE COUNTY TO CONTINUE TO STAY AT HOME OR AT THEIR PLACE OF
RESIDENCE EXCEPT THAT THEY MAY LEAVE TO PROVIDE OR
RECEIVE CERTAIN ESSENTIAL SERVICES OR ENGAGE IN CERTAIN
ESSENTIAL ACTIVITIES AND WORK FOR ESSENTIAL BUSINESSES
AND GOVERNMENTAL SERVICES; DIRECTING ALL BUSINESSES AND
GOVERNMENTAL AGENCIES TO CEASE NON-ESSENTIAL
OPERATIONS AT PHYSICAL LOCATIONS IN THE COUNTY;
PROHIBITING ALL NON-ESSENTIAL GATHERINGS OF ANY NUMBER
OF INDIVIDUALS; ORDERING CESSATION OF ALL NON-ESSENTIAL TRAVEL;
RESTRICTING ACCESS TO CERTAIN RECREATION AREAS; AND ORDERING
MINIMUM REQUIREMENTS FOR BUSINESS SOCIAL DISTANCING AND SAFETY
PLANS

DATE OF ORDER: April 24, 2020

Please read this Order carefully. Violation of or failure to comply with this Order is a misdemeanor punishable by fine, imprisonment, or both. [California Health and Safety Code, Section 120295, *et seq.*; Government Code, Section 8665; Penal Code, Section 148(a)(1)]

UNDER THE AUTHORITY OF CALIFORNIA HEALTH AND SAFETY CODE SECTIONS 101040, 101085, AND 120175, THE HEALTH OFFICER OF THE COUNTY OF MERCED (“HEALTH OFFICER”) ORDERS:

1. This Order supersedes the April 17, 2020, Order of the Health Officer directing all individuals to stay at home (“Prior Stay at Home Order”). This Order clarifies, strengthens, and extends certain terms of the Prior Stay at Home Order to increase social distancing and reduce person-to-person contact in order to further slow transmission of Novel Coronavirus Disease 2019 (“COVID-19”). As of the effective date and time of this Order set forth in Section 16 below, all individuals, businesses, entities, and government agencies in the County of Merced (the “County”) are required to follow the provisions of this Order.
2. The intent of this Order is to ensure that the maximum number of people self-isolate in their places of residence to the maximum extent feasible, while enabling essential services to continue, to slow the spread of COVID-19 to the maximum extent possible. When people need to leave their places of residence, whether to obtain or perform vital services, or to otherwise facilitate authorized activities necessary for continuity of social and commercial life, they should at all times reasonably possible comply with Social Distancing Requirements as defined in Section 13 below. All provisions of this Order should be interpreted to effectuate this intent. Failure to

comply with any of the provisions of this Order constitutes an imminent threat to public health.

3. In accordance with the Order of the State Public Health Officer and the California Governor's Executive Order N-33-20 both issued on March 19, 2020, all individuals currently living within the County are ordered to shelter at their place of residence. To the extent individuals are using shared or outdoor spaces, they must at all times as reasonably possible maintain social distancing of at least six feet from any other person when they are outside their residence. All persons may leave their residences only for Essential Activities, Essential Governmental Functions, or to operate Essential Businesses, all as defined in Section 13. Individuals experiencing homelessness are exempt from this Section, but are strongly urged to obtain shelter, and governmental and other entities are strongly urged to make such shelter available as soon as possible and to the maximum extent practicable (and to utilize Social Distancing Requirements in their operation).

Further, the State of California issued a clarification of the Governor's Order on April 17, 2020. More specifically, the State confirmed that in-person services are prohibited but clarified that "...drive-in worship services are permitted under the existing Executive Order, which expressly allows "[f]aith based services that are provided through...other technology," as long as the individuals engaged in such services abide by physical distancing guidelines and refrain from direct and indirect physical touching of others." In other words, faith-based services that are provided through streaming or other technology including drive-in services are considered essential under the Governor's Order. Faith-based services shall follow approved operational guidelines provided by the Merced County Department of Public Health.

4. All businesses with a facility in the County, except Essential Businesses as defined below in Section 13, are required to cease all activities at facilities located within the County except Minimum Basic Operations, as defined in Section 13. For clarity, businesses may also continue operations consisting exclusively of employees or contractors performing activities at their own residences (i.e., working from home). All Essential Businesses are strongly encouraged to remain open. To the greatest extent feasible, Essential Businesses shall comply with Social Distancing Requirements as defined in Section 13 below, including, but not limited to, when any customers are standing in line.
5. All essential businesses shall be required to develop a Social Distancing and Safety Plan. This section shall become effective immediately and will be enforced effective Friday, May 1, 2020, at 8:00 a.m. Individual jurisdictions may create stricter guidelines for implementation. The following minimum requirements must be included within each Social Distancing and Safety Plan:
 - a. Limitation of capacity of business to 5 people per 1,000 square feet.

- b. Door monitoring of individuals in and out of doors to ensure appropriate numbers are maintained.
 - c. One adult may enter the business per party/cart. One additional person may accompany an individual with disabilities or otherwise requires assistance with shopping. No large family visits.
 - d. Provide hand sanitizer or disinfecting wipes at all entrances and exits.
 - e. Social distancing must be ensured through:
 - i. Clearly marked one-way aisles
 - ii. Clearly marked check-out lines with at least 6 feet in between customers
 - iii. Clearly marked lines for entry into the business with at least 6 feet in between customers
 - f. Employees shall wipe down all carts and baskets using disinfectant.
 - g. Provide adequate handwashing facilities for employees.
 - h. All employees must wear cloth masks, to be provided by the employer.
 - i. All visitors to a business should wear a cloth mask. Individuals not wearing a mask may be denied entry into the business.
 - j. Customers must bag their own groceries/items when bringing reusable bags. Employees shall use new bags when bagging customer groceries/items.
 - k. All workers who are able to telecommute should be allowed to do so.
 - l. All workers must be given adequate protections whenever possible, including social distancing of employees at least 6 feet from each other, and/or shields between employees and customers.
 - m. Universal screening of all employees for fever, cough, and shortness of breath shall occur (already included in the Febrile Respiratory Illness Health Officer Order dated April 7, 2020).
6. All public and private gatherings of any number of people occurring outside a household or living unit are prohibited, except for the limited purposes as expressly permitted in Section 13. All bars, wineries and brew-pubs should be closed, all in-dining at restaurants should cease, with the exception of home delivery and takeout, and all gyms, bingo halls, and card rooms should close. Nothing in this Order prohibits the gathering of members of a household or living unit.
7. All agencies, jurisdictions, entities, individuals, businesses, companies, private or public, owning or operating parks are hereby directed to cease all operations and services of certain park facilities within the County, closing all park picnic areas, lake facilities, playgrounds, skateboard parks, basketball courts, volleyball courts, and indoor facilities in parks, and shall prevent all public and motorized access by use of signage and physical barrier wherever possible, except access to walking trails, bicycle paths, and green spaces is allowed. Golf courses will only be allowed to operate if following approved operational guidelines provided by the Merced County Department of Public Health. Individuals accessing walking trails, bicycle paths, or green spaces in parks, and golf courses, shall follow Social Distancing Requirements.

- a. Such access to walking trails, bicycle paths, and green spaces shall be exclusively by non-motorized means, except that disabled persons with vehicles possessing current and valid disabled person parking placards or disabled person license plates may continue to access parks by motorized means but only to the minimum extent necessary to engage in Essential Activities at walking trails, bicycle paths, and green spaces.
 - b. All park facilities, including green spaces and golf courses, must be fully closed on major holiday weekends, including Mother's Day weekend, Memorial Day weekend, Father's Day weekend, and 4th of July weekend.
8. All travel, including, but not limited to, travel on foot, bicycle, scooter, motorcycle, automobile, or public transit, except Essential Travel and Essential Activities as defined below in Section 13, is prohibited. People must use public transit only for purposes of performing Essential Activities or to travel to and from work to operate Essential Businesses or maintain Essential Governmental Functions. People riding on public transit must comply with Social Distancing Requirements as defined in Section 13 below, to the greatest extent feasible. This Order allows travel into or out of the County to perform Essential Activities, operate Essential Businesses, or maintain Essential Governmental Functions.
9. This Order is issued based on evidence of increasing occurrence of COVID-19 throughout the state, scientific evidence and best practices regarding the most effective approaches to slow the transmission of communicable diseases generally and COVID19 specifically, and evidence that the age, condition, and health of a significant portion of the population of the County places it at risk for serious health complications, including death, from COVID-19. Due to the outbreak of the COVID-19 virus in the general public, which is now a pandemic according to the World Health Organization, there is a public health emergency throughout the County. Making the problem worse, some individuals who contract the COVID-19 virus have no symptoms or have mild symptoms, which means they may not be aware they carry the virus. Because even people without symptoms can transmit the disease, and because evidence shows the disease is easily spread, gatherings can result in the transmission of the virus. The scientific evidence shows that at this stage of the emergency, it is essential to slow virus transmission as much as possible to protect the most vulnerable and to prevent the health care system from being overwhelmed. One proven way to slow the transmission is to limit interactions among people to the greatest extent practicable. By reducing the spread of the COVID-19 virus, this Order helps preserve critical and limited healthcare capacity in the County.
10. This Order also is issued in light of a significant and increasing number of suspected cases of community transmission and likely further significant increases in transmission. Widespread testing for COVID-19 is not yet available but is expected to increase in the coming days. This Order is necessary to slow the rate of spread and the Health Officer will re-evaluate it as further data becomes available.

11. This Order is issued in accordance with, and incorporates by reference, the following:
 - a) The Proclamation of the State of Emergency issued by Governor Gavin Newsom on March 4, 2020.
 - b) Executive Order N-25-20 issued by Governor Gavin Newsom on March 12, 2020.
 - c) Proclamation on Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) Outbreak issued by the President of the United States on March 13, 2020.
 - d) Order of the Merced County Health Officer on March 13, 2020.
 - e) Executive Order N-33-20 issued by Governor Gavin Newsom on March 19, 2020.
 - f) Order of the State Public Health Officer issued on March 19, 2020.

12. This Order comes after the release of substantial guidance from the County Health Department, the Centers for Disease Control and Prevention, the California Department of Public Health, and other public health officials throughout the United States and around the world, including a variety of prior orders to combat the spread and harms of COVID-19. The Health Officer will continue to assess the quickly evolving situation and may modify or extend this Order, or issue additional Orders, related to COVID-19.

13. Definitions and Exemptions.
 - a. For purposes of this Order, individuals may leave their residence only to perform any of the following “Essential Activities.” But people at high risk of severe illness from COVID-19 and people who are sick are urged to stay in their residence to the extent possible except as necessary to seek medical care.
 - i. To engage in activities or perform tasks essential to their health and safety, or to the health and safety of their family or household members (including, but not limited to, pets), such as, by way of example only and without limitation, obtaining medical supplies or medication, visiting a health care professional, or obtaining supplies they need to work from home.
 - ii. To obtain necessary services or supplies for themselves and their family or household members, or to deliver those services or supplies to others, such as, by way of example only and without limitation, canned food, dry goods, fresh fruits and vegetables, pet supply, fresh meats, fish, and poultry, and any other household consumer products, and products necessary to maintain the safety, sanitation, and essential operation of residence.

- iii. To engage in outdoor activity, provided the individuals comply with Social Distancing Requirements as defined in this Section and all requirements of this Order.
 - iv. To perform work providing essential products and services at an Essential Business or to otherwise carry out activities specifically permitted in this Order, including Minimum Basic Operations.
 - v. To care for a family member or pet in another household.
- b. For purposes of this Order, individuals may leave their residence to work for or obtain services at any “Healthcare Operations” including hospitals, clinics, dentists, pharmacies, pharmaceutical and biotechnology companies, other healthcare facilities, healthcare suppliers, home healthcare services providers, mental health providers, or any related and/or ancillary healthcare services. “Healthcare Operations” also includes veterinary care and all healthcare services provided to animals. This exemption shall be construed broadly to avoid any impacts to the delivery of healthcare, broadly defined. “Healthcare Operations” does not include fitness and exercise gyms and similar facilities.
- c. For purposes of this Order, individuals may leave their residence to provide any services or perform any work necessary to the operations and maintenance of “Essential Infrastructure,” including, but not limited to, public works construction, residential and commercial construction, airport operations, water, sewer, gas, electrical, oil refining, roads and highways, public transportation, solid waste collection and removal, internet, and telecommunications systems (including the provision of essential global, national, and local infrastructure for computing services, business infrastructure, communications, and web-based services), provided that they carry out those services or that work in compliance with Social Distancing Requirements as defined this Section, to the extent possible.
- d. For purposes of this Order, all first responders, emergency management personnel, emergency dispatchers, court personnel, and law enforcement personnel, and others who need to perform essential services are categorically exempt from this Order. Further, nothing in this Order shall prohibit any individual from performing or accessing “Essential Governmental Functions,” as determined by the governmental entity performing those functions. Each governmental entity shall identify and designate appropriate employees or contractors to continue providing and carrying out any Essential

Governmental Functions. All Essential Governmental Functions shall be performed in compliance with Social Distancing Requirements as defined in this Section, to the extent possible.

- e. For the purposes of this Order, covered businesses include any for-profit, nonprofit, or educational entities, regardless of the nature of the service, the function they perform, or its corporate or entity structure.
- f. For the purposes of this Order, “Essential Businesses” means:
 - i. Healthcare Operations and Essential Infrastructure;
 - ii. Grocery stores, certified farmers’ markets, farm and produce stands, supermarkets, food banks, convenience stores, and other establishments engaged in the retail sale of canned food, dry goods, fresh fruits and vegetables, pet supply, fresh meats, fish, and poultry, and any other household consumer products (such as cleaning and personal care products). This includes stores that sell groceries and also sell other non-grocery products, and products necessary to maintaining the safety, sanitation, and essential operation of residences;
 - iii. Agriculture, food, and beverage cultivation, processing, testing and distribution, including but not limited to, farming, ranching, fishing, dairies, creameries, wineries and breweries in order to preserve inventory and production (not for retail business), as well as business activities that support production and processing by providing essential agricultural supplies and services, including but not limited to, transportation, manufacturing, chemicals, equipment, and services such as cooling, storing, packing, and distribution of such products for wholesale or retail sale;
 - iv. Businesses that provide food, shelter, and social services, and other necessities of life for economically disadvantaged or otherwise needy individuals;
 - v. Newspapers, television, radio, and other media services;
 - vi. Gas stations and auto-supply, sales and auto-repair, and related facilities;
 - vii. Banks and related financial institutions;
 - viii. Hardware stores;
 - ix. Animal care facilities that provide food, shelter, veterinary and/or routine care and other necessities of life for animals including dog grooming facilities, dog day care facilities, animal rescue facilities, and boarding facilities when keeping a six-foot distance between customers and

- employees/owners and properly disinfecting affected surfaces and equipment;
- x. Plumbers, electricians, exterminators, custodial/janitorial workers, handyman services, funeral home workers and morticians, moving services, HVAC installers, carpenters, vegetations services, tree maintenance, landscapers, gardeners, pool maintenance, property managers, private security personnel and other service providers who provide services to maintain the safety, sanitation, and essential operation to properties and other Essential Businesses.
 - xi. Drive-thru automatic car wash businesses where customers remain in their cars and where the vacuum centers are closed, and mobile detailing services, keeping a six-foot distance between customers and employees with no cash exchange;
 - xii. Businesses providing mailing and shipping services, including post office boxes;
 - xiii. Educational institutions—including public and private K-12 schools, colleges, and universities—for purposes of facilitating distance learning or performing essential functions, provided that social distancing of six feet per person is maintained to the greatest extent possible;
 - xiv. Laundromats, drycleaners, and laundry service providers;
 - xv. Restaurants and other facilities that prepare and serve food, but only for delivery or carry out. Schools and other entities that typically provide free food services to students or members of the public may continue to do so under this Order on the condition that the food is provided to students or members of the public on a pick-up and take-away basis only. Schools and other entities that provide food services under this exemption shall not permit the food to be eaten at the site where it is provided, or at any other gathering site;
 - xvi. Businesses that supply products needed for people to work from home;
 - xvii. Businesses that supply other essential businesses with the support or supplies necessary to operate;
 - xviii. Businesses that ship or deliver groceries, food, goods or services directly to residences;
 - xix. Airlines, taxis, and other private transportation providers providing transportation services necessary for Essential Activities and other purposes expressly authorized in this Order;
 - xx. Home-based care for seniors, adults, or children;

- xxi. Residential facilities and shelters for seniors, adults, and children;
 - xxii. Professional services, such as legal or accounting services, when necessary to assist in compliance with legally mandated activities;
 - xxiii. Delivery services that provide transport of essential products, such as water, food and household products;
 - xxiv. Childcare facilities providing services that enable employees exempted in this Order to work as permitted. To the extent possible, childcare facilities must operate under the following mandatory conditions:
 - 1. Childcare must be carried out in stable groups of 12 or fewer (“stable” means that the same 12 or fewer children are in the same group each day).
 - 2. Children shall not change from one group to another.
 - 3. If more than one group of children is cared for at one facility, each group shall be in a separate room. Groups shall not mix with each other.
 - 4. Childcare providers shall remain solely with one group of children.
- g. For the purposes of this Order, “Minimum Basic Operations” include the following, provided that employees comply with Social Distancing Requirements as defined this Section, to the extent possible, while carrying out such operations:
- i. The minimum necessary activities to maintain the value of the business’s inventory, ensure security, process payroll and employee benefits, or for related functions.
 - ii. The minimum necessary activities to facilitate employees of the business being able to continue to work remotely from their residences.
- h. For the purposes of this Order, “Essential Travel” includes travel for any of the following purposes. Individuals engaged in any Essential Travel must comply with all Social Distancing Requirements as defined in this Section below.
- i. Any travel related to the provision of or access to Essential Activities, Essential Governmental Functions, Essential Businesses, or Minimum Basic Operations.
 - ii. Travel to care for elderly, minors, dependents, persons with disabilities, or other vulnerable persons.
 - iii. Travel to or from educational institutions for purposes of receiving materials for distance learning, for receiving meals, and any other related services.

- iv. Travel to return to a place of residence from outside the jurisdiction.
 - v. Travel required by law enforcement or court order.
 - vi. Travel required for non-residents to return to their place of residence outside the County.
- i. For purposes of this Order, residences include hotels, motels, shared rental units and similar facilities.
 - j. For purposes of this Order, “Social Distancing Requirements” includes maintaining at least six-foot social distancing from other individuals, washing hands with soap and water for at least twenty seconds as frequently as possible or using hand sanitizer, covering coughs or sneezes (into the sleeve or elbow, not hands), regularly cleaning high-touch surfaces, and not shaking hands.
14. Pursuant to Government Code Sections 26602 and 41601 and Health and Safety Code Sections 101029 and 131080, the Health Officer requests that the Sheriff and all chiefs of police in the County ensure compliance with and enforce this Order. The violation of any provision of this Order constitutes an imminent threat to public health.
15. In accordance with California Health and Safety Code section 131080, the Health Officer will follow the guidance of the California Department of Public Health and may modify or extend this Order, or issue additional Orders.
16. This Order shall become effective immediately and continue until it is rescinded, superseded, or amended in writing by the Health Officer.
17. Copies of this Order shall promptly be: (1) made available at the County Administration Building at 2222 M Street, Merced, California 95340; (2) posted on the County Public Health Department’s website (countyofmerced.com); and (3) provided to any member of the public requesting a copy of this Order.
18. If any provision of this Order to the application thereof to any person or circumstance is held to be invalid, the remainder of the Order, including the application of such part or provision to other persons or circumstances, shall not be affected and shall continue in full force and effect. To this end, the provisions of this Order are severable.

COVID-19 Worship Services Safe Distance Rules
During Effective Dates of Stay at Home Order**

Note these guidelines provided are the minimum requirements that must be enforced. Churches and other worship facilities are able to develop policies that are more stringent if they feel they are necessary to ensure the health and safety of persons using their facilities or participating in their services.

Churches and faith-based organizations are responsible for ensuring compliance of their individuals utilizing their facilities and participating in their services. For all activities, CDC Guidance shall be followed in order to prepare and respond appropriately to COVID-19; see the following CDC link and follow the recommendations for “Substantial Community Spread” as well as all Merced County Health Officer Orders and guidance documents: <https://www.cdc.gov/coronavirus/2019-ncov/community/organizations/guidance-community-faith-organizations.html>. Drive-in Worship Services Allowed with Restrictions

1. Drive-in worship services utilizing technology are allowed only if all of the following occurs:
 - a. Vehicles must be parked in every other parking space, leaving an empty parking space in between each vehicle.
 - b. Each vehicle must contain only members of the same household/residence.
 - c. Choirs or singing groups are prohibited.
 - d. As few as possible, but no more than 10 people are allowed to participate in the providing of each service for worshippers, including a pastor, facilitator, greeter, musician/singer, technical assistance for equipment, etc.
 - e. All speakers must be 10 feet apart. Only one speaker is allowed at a time. Speakers should be limited, and shall disinfect podiums/microphones in between speakers. Microphones shall not be passed off hand to hand between persons.
 - f. Individuals integral to the services outside of vehicles shall maintain a 10-foot distance from vehicles.
 - g. There shall be no person-to-person contact between individuals outside of their vehicles.
 - h. Printed materials, or any other items, shall not be passed out to or exchanged between worshippers. Electronic applications or e-mail may be used for viewing of materials or song script.
 - i. When a vehicle window(s) is open, all occupants of the vehicle must wear masks, except that cloth face coverings should not be placed on young children under age 2 or anyone who has trouble breathing per CDC guidelines: <https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/diy-cloth-face-coverings.html>.
 - j. Music shall be limited to one instrument plus one singer, who must be more than 10 feet apart from anyone else. Singing is a higher risk activity for transmission of COVID-19. Microphones used by singers shall not be shared with anyone else during the service, and shall be properly disinfected before next use.
 - k. There shall be no collection plate passing. Collection boxes can be set up that are accessible via drive-thru, but must not be held by a person.

- l. No food consumption will be allowed, including when related to religious practices (e.g., communion).
- m. On-site restroom facilities shall not be used by individuals attending drive-in worship services.

Remote Access Worship Services Allowed with Restrictions

1. To assist individuals with the ability to stay at home whenever possible, remote access to worship services is allowed through e-mail, video streaming, or teleconference and is preferred by the Department of Public Health as the safer option to prevent the spread of COVID-19; there is no in-person attendance of worshippers allowed for remote access services.
 - a. Services held at a church, synagogue, mosque, or other public place of worship shall involve as few people as possible, but not allow more than 10 people to participate in the providing of remote services for worshippers, including a pastor, facilitator, greeter, musician/singer, technical assistance for equipment/video, etc.
 - i. Choirs or singing groups are prohibited.
 - ii. All speakers must be 10 feet apart. Only one speaker is allowed at a time. Speakers should be limited, and shall disinfect podiums/microphones in between speakers. Microphones shall not be passed off hand to hand between persons.
 - iii. There shall be no person-to-person contact between individuals.
 - iv. Music shall be limited to one instrument plus one singer, who must be more than 10 feet apart from anyone else. Singing is a higher risk activity for transmission of COVID-19. Microphones used by singers shall not be shared with anyone else during the service, and shall be properly disinfected before next use.
 - v. No food consumption will be allowed, including when related to religious practices (e.g., communion).
 - b. If religious leaders choose to broadcast video streaming or teleconference services from their private home, only individuals living within the household shall participate in providing the remote services for worshippers.

COVID-19 Golf Safe Distance Rules
During Effective Dates of Stay at Home Order**

Note these guidelines are a compilation of many clubs' best practices. These are the minimum requirements that must be enforced; Clubs are able to enforce policies that are more stringent if they feel they are necessary to ensure the health and safety of persons using their facilities.

Clubs are responsible for ensuring compliance of their individuals utilizing their facilities.

Facilities

1. All clubhouse and indoor facilities are and shall remain closed, including, but not limited to the Pro Shop, Bar, and Restaurants.
2. Driving ranges may remain open only if automatic ball cleaners are utilized and a person does not directly conduct the golf ball cleaning.
3. If restrooms remain open, cleaning must be increased to all touch points at least 4 times per day.
4. Check in, if required, must be completed outside, with social distancing of at least 6 feet while both golfer and staff are masked, or through a Plexiglas-type shield.
5. Expand tee time intervals to ensure social distancing.

Persons Allowed on Courses

1. Outdoor areas of golf clubs are open only by tee time appointment for appropriate outdoor activities, including the playing of golf pursuant to COVID-19 Golf Safe Distances Rules.
2. Persons who are symptomatic with cough, fever, or shortness of breath, or are housed with anyone symptomatic are prohibited from being on site until those symptoms have subsided for at least fourteen (14) days. A negative COVID-19 test result does not overrule the recommended quarantine, due to potential testing false negatives.
3. Any person who is quarantined by order of a medical or governmental official is prohibited from being on site until the quarantine is lifted.
4. Except for persons of the same household, persons who drive their vehicle to the site should do so alone and park, if possible, at least one space apart. At all times, those who are not persons of the same household using the course, including parking areas, shall stay at least ten (10) feet away from all other users.
5. Those golfing must have no more than 4 players in any group. Social distancing MUST be maintained around the green.
6. Only one person per golf cart.

7. Patrons must wait in their cars until their designated tee times. No social gathering while waiting for the round to begin. Patrons must go directly from hole 18 to their car. No social gathering following the round.
8. Any and all contact with golf course staff, including payment processing, will be done telephonically or electronically, with the exception of check in, if required (see facility rules, above). No cash payments.
9. Limited staff may remain on site for basic facility/grounds maintenance, security, and to ensure compliance with these rules. However, staff must remain 6 feet from all patrons, and wear a mask during interactions.

Equipment

1. No rental clubs or balls may be used and all patrons must bring and use their own equipment.
2. If patrons wish to pick up golf clubs or pull carts from the bag/cart storage, arrangements to do so must be made electronically in advance with staff who will remove the equipment and leave it outside in a designated location. The equipment will not be returned to storage until regular play is resumed (the patrons must then take their equipment with them). This equipment must be the patron's personal equipment.
3. Golf cart rentals should be limited whenever possible, and arranged in advance, electronically or over the phone.
 - a. When possible, if the requesting patron does not have a personal cart, a cart number will be assigned to the requesting patron and that cart shall be used only by that patron and the patron's household during the duration of these rules.
 - b. Golf carts must be picked up and dropped off outside by masked staff maintaining 6 feet or more social distance from any patrons.
 - c. Golf carts must be cleaned and sanitized between each use, and before staff move them back into storage.
 - d. Only one person per golf cart.
4. All rakes, ball washers, and sand bottles must be removed to avoid cross-contamination. If a ball lands in a spot that would otherwise have been raked (e.g. a footprint or divot), the ball can be placed in the nearest undamaged portion of the bunker.
5. The golf cups and flags must be modified to prevent the ball from going into the cup. Flagstick or the base holding the flagstick in place must not be touched or removed. Courses must provide alternative ways to remove balls from holes that do not require human contact, or alternative rules (e.g., putts within two feet are to be conceded to minimize the possibility of contact with the hole and stick.)
6. Except for persons of the same household, players should not touch another player's ball, equipment, or cell phone, including scorecards and pencils.

COVID-19 Funeral Services FAQs
During Effective Dates of Stay at Home Order**

I operate a funeral home. Are funeral services allowed?

Yes, with restrictions. Gatherings are a significant contributor to the spread of COVID-19, requiring restrictions to allow for a balance between safety and beliefs, rituals, and traditions. If the following guidelines cannot be followed, visitors will not be allowed.

Funeral services or viewings are not allowed to take place off-site or in a private home.

While direct burial or direct cremation with no persons in attendance is preferred, funeral services may take place by remote access through video streaming, cemetery graveside, or cemetery drive-through with as few people present as possible. No more than 10 persons including clergy and technical assistance shall be present for funeral services; no rotation of those 10 persons is allowed. Family shall disclose to clergy if decedent is COVID-19 positive. No ill persons shall be in attendance of funeral services or viewings. All persons must wear a mask and maintain social distancing of 6 feet from other individuals. Mortuary visitation or viewing shall be no more than 30 minutes. Graveside visits shall be for no more than 15 minutes. No more than 10 cars are allowed at a cemetery. Cemeteries are temporarily closed for regular visitation, at this time.
